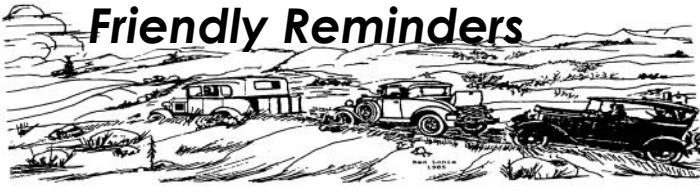

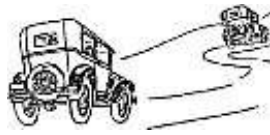

A motion from Diablo A's past presidents:

Recently, our Board of Directors has changed a long-standing policy and has stopped publishing minutes of Board meetings in the MotoMeter newsletter. The explanation offered is that there is only one other club publishing its board minutes and we don't want everyone to know our business.

In fact, we have a long tradition of sharing with our members what the Board of Directors do at their meetings. Our members have a right to know what actions the Board has taken on all issues it discusses. We have never published dollars in the minutes regardless of the subject. There is nothing that should be withheld from our members and there is no reason anyone else shouldn't also know. The Board should have no secrets from anyone, inside or outside of our club. Board business is not confidential. It is not secret. And, it should not be treated that way.

Another argument suggests minutes can only be approved at a subsequent Board meeting. That is also not true. We have a long history of routing Board meeting minutes to Board members by email. Email has also been the vehicle for attaining approval or corrections to those minutes. That procedure has always allowed publication of the minutes in the upcoming MotoMeter.

Collectively, we 14 former Diablo A's presidents put forth the following motion and urge members to approve it.

We move that the following procedure be adopted by the Diablo A's club and be immediately implemented by its Board of Directors.

1. The Secretary will prepare minutes of each Board meeting and send them to each voting Board member for changes or approval.
2. Board members will send the Secretary all changes, or their approval. Absence of a reply will constitute approval.
3. The Editor of the MotoMeter will include Board minutes in the same month's edition of our newsletter and distribute copies to members prior to the next general meeting.

Our members must have access to Board meeting minutes in each edition of the newsletter. Anything less allows the Board to protect its actions from scrutiny. As part presidents of Diablo A's we want to see our club offer fun for members not contention. We ask that you join us and approve this motion for openness in our club operations. The current arrangement is just unacceptable.

Aprons make acceptable gifts!

Aprons have been around a long time but there are lots of choices today.

They appeared in Medieval and Renaissance paintings and mostly looked like they were rectangles of cloth. Today they are more of a fashion statement but just as utilitarian. In the past people did not have the luxury of a large wardrobe nor did they have the laundry facilities as we have today so aprons served the purpose of covering your dress to protect it from soiling. The apron could be washed every couple of days or more often whereas the dress under the apron maybe only was washed once a week.

Aprons followed the lines of the dress during the 1920's, long and no waistline. During later years, they were sometimes cinched at the waist.

Up until the 1940's large quantities of flour and chicken feed arrived in cotton sacks and were durable enough to withstand washings and rough handling. The sacks came in bright, colorful, floral patterns. If the apron had seen its better day, the best parts were cut out and used for quilts. No wasting in those days!

I always thought an apron was an apron but they had different names:

Full apron – covers the whole front —Half apron – tied at the waist, no bib —Princess apron – full apron with bib and skirt, cut in one piece and no waist seam. This style was very popular in the 1920's and 1930's. —Pinafore – bib style that covered the chest and fastened with a pin, thus the name —Pinny – British slang for pinafore or apron —Hostess—50's term for a half apron, dainty fabric and made for show —Bib – top portion of apron that covers the chest and made from a simple square —Smock – more like a dress. Popular for painting and gardening —Cobbler – covers front and back, generally straight with ties or buttons at the sides —Chef's – one piece with straight 'skirt' and bib. Ties in the back So when you need a gift, think of an apron. There are lots of patterns to choose from!

Muffler Tail Pipe Clamp

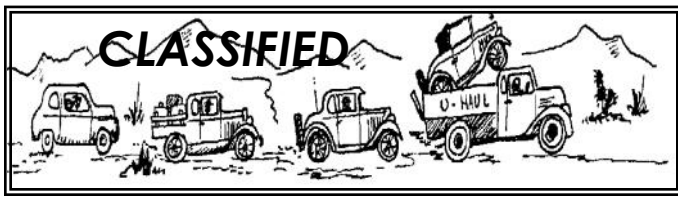

Have you ever wondered why the exhaust manifold on a Model A becomes distorted and leaks after years of operation? Why the outlet of the manifold is no longer vertical? No, that condition is not normal; they were always that way.

There is a reason for this and it is not just because of continuous heating and cooling. Many people installing the muffler will tighten the clamp bolt where it fastens the muffler/tail pipe to the frame, obviously to keep it from rattling.

This bolt is only supposed to be little more than hand tight. That is the reason for the castellated nut and cotter pin; so that the bolt will not become unscrewed and fall off. The reason for this is to allow the tail pipe to slide forward and backward when the exhaust system is heated and cooled alternatively. When the clamp is tightened the exhaust manifold actually bends when the muffler expands. Yes, cast iron will "bend" under these conditions.

So remember, do not over tighten your muffler/tail pipe clamp.

Courthouses of Contra Costa

After the county was formed in 1850 F. M. Warmcastle was elected judge of the court of sessions, replacing Alcade Elam Brown. Court trials were held in private homes at first because there was no courthouse (or any other public building, except for a jail). In 1854 a two-story brick courthouse was built on Court Street, Martinez. It had a small bell tower on top. The bell was used to call court to session. The courthouse shown here is as it appeared in 1890, amid a small park with curving paths.



County government outgrew the original courthouse and it was replaced in 1901 by the building shown next, located at Pine and Escobar Streets.



This Greco-Roman structure served as the count's only big office and courts building until 1933, when the Hall of Records was built. In 1954 the supervisors were worried about the cupola falling through the roof of the courthouse if there were an earthquake and ordered the cupola removed. When the contractor got started on the job in July 1956 it was found that the sheet-iron cupola was quite sturdy and that the fears were unjustified. However, since he had a contract to remove it, the contractor went ahead with the job, taking the cupola apart piece by piece. The job took until March 1957. In 1964 a 12-story county administration building was completed, initiating the movement of various county departments. In 1966 the courts and the designation "courthouse" were shifted to the Hall of Records and the building in the photo became the Public Finance Building.

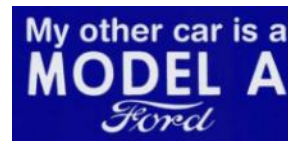
